Minutes of Called Meeting Elbert County Board of Commissioners Thursday, September 30, 2021

Chairman Lee Vaughn called the meeting to order. Adoption of the Agenda. Chairman asked for a motion to amend the agenda to add 9a) Executive Session. Commissioner Ashworth made a motion to adopt the agenda as amended. Commissioner Freeman seconded the motion. The motion passed 5-0.

Discussion and approval of a Resolution to adopt the Northeast Georgia Regional Solid Waste Management Plan. Commissioner Freeman made a motion to adopt the Northeast Georgia Regional Solid Waste plan. Commissioner Harper seconded the motion. The motion passed 5-0.

Discussion and approval to adopt the Millage Rate for the Elbert County Board of Education. Commissioner Ashworth made a motion to adopt the Board of Education's millage rate of 14.250. Commissioner Harper seconded the motion. The motion passed 5-0.

Discussion and approval to adopt the Millage Rate for the Elbert County Board of Commissioners. Commissioner Freeman made a motion to adopt the millage rate of 9.7630 for the unincorporated area of the county and 10.539 for the incorporated area. Commissioner Jones seconded the motion. The motion passed 5-0.

Discussion and approval to approve the Sonny Solar Decommissioning Agreement. Mr. Daughtry stated Mr. Allen Hulme and agents for Sonny Solar has agreed to a decommissioning guarantee of \$2,628,869.21 which is the amount that both parties have agreed upon for the cost of removing panels and getting the ground back to its original condition; that is if the project ceases to operate for a period of 365 consecutive days. This is a requirement under out zoning ordinance. Commission Freeman made a motion to approve the Decommissioning Agreement with Sonny Solar. Commissioner Ashworth seconded the motion. The motion passed 5-0.
